H. AUDIENCE PARTICIPATION

Council received comments from the following people:

Sadonna Myers: Trees that need to be removed at Library, barn (where, when and how big), cleanup the library for Memorial Day.

Anthony Lachcik of Burton - Council disrespecting the neighborhood where employees live and putting down the city employees.

John Stapish of Burton - He received no reply on his question about house numbers on every house. Thought the benefits for Council should be considered that Mr. Hatfield brought up. No reponse on the sidewalk distance from the curbs.

Randy Hendrick of Burton - About repair to N. Center Road

Allan Bontumasi of Burton - About DPW workers doing a great job. Would rather had the reduction in taxes put to roads instead of getting it back.

Chris Howser of Burton - Council misconception about DPW being lazy. Council states that residents can't take any more hits but neither can the City employees.

Mr. Haskins called point of order: he has never heard anything directly from City Council stating the DPW is lazy. Where is this coming from?

Mr. Howser stated it is coming from multiple people including residents.

Judy Estes of Burton - Thank you for having the houses demolished.

Brandon Verdier of Burton - Panhandlers Ordinance

I. COUNCIL DISCUSSION

Mr. Smith addressed residents leaving Burton, legacy costs, roads and lack of money to fix them. I would like to see the residents put together a committee for roads. I get multiple complaints from residents about the DPW that I pass on to the Mayor. There are only 6 employees back there and I know they work hard. In this economy, we don't have enough money to make everyone happy. I have been negligent on getting the house numbers for Mr. Stapish, I would like to ask the administration to get clarification on that.

Mr. Hatfield stated we are the only state in the country that declined in revenue sharing and this took the money out of our budget to fix the roads. This council promised to use the 6.5 mills to attack legacy debt and I think we need to continue doing that. Last year, the council approved a budget at 4.707 mills then we lowered the operating mills to 4.0 and had to go back and cut the budget. I voted no because in my opinion, that is not being wise with the city's money. I would have liked to have seen that money pay our debt but I would have accepted using it to fix some roads. We will have to fix the roads a little at a time. If the citizens want to come together with a road millage proposal, other communities have done that. I urge you to write your Congressman and State Reps to get our revenue sharing back.

Mr. Haskins discussed the drug paraphernalia law. This is not a new ordinance, it is just tightening up the language because it was vague and confusing in the courts. This is for people who are doing it illegally. Regarding the panhandling ordinance, we have had numerous complaints about this and it is tough to determine who is actually in need and who is running a scam. How is the traffic control order for the stop signs going on Judd Road?

Mr. Slattery stated he is currently doing a traffic study there based on the recommendation of the Michigan Manual and the National Manual of Uniform Traffic Control Devices. We are collecting speeds and traffic counts on Judd Road from Saginaw Street to Dort Highway and on Barnes, Columbine and Fern. We are also getting accident counts on Judd Road. I have talked with the Police Chief and he concurs that we need to look at this very carefully before placing stop signs there. Additionally, I am told by the Michigan State Police that a traffic study should be done and that once you put a stop sign in place it is difficult to remove it without negative implications, accidents perhaps. I will report back with a recommendation when the traffic study is complete.

Mr. Haskins stated this wasn't developed for traffic crashes but for the speeds and the kids playing in that area. The residents have addressed this numerous times. Unless the state tells us it is illegal to put stop signs there, this council voted unanimously to put them there so they need to be put in.

Mr. Slattery stated it isn't exactly against the law but it is against the better judgement of all traffic professionals. I don't want to be responsible for causing accidents there. I am doing my due diligence. It's a truism in the road industry that stop signs do not work for speed control they essentially tend to increase speeds between stop signs.

Mr. Martinbianco stated this is similar to when we put stop signs in on Term Street between Atherton and Lippincott which we did without a traffic study.

Chief Osterholzer stated we do get many complaints about speeding on Judd Road and we cannot monitor it with traffic enforcement around the clock. Mr. Slattery showed me the legislation and we felt it wise to do the traffic study and prudent to have the traffic study results before coming back to City Council with our recommendation.

Mr. Haskins stated this should have been brought to the council 4-6 weeks ago so we could have addressed it.

Mr. Slattery stated we are doing it the right way, the professional way. I apologize if I didn't report this to you soon enough.

Mr. Haskins said this council didn't give a directive to do a traffic study the directive of the City Council with a 7-0 vote was to put in stop signs. They need to be put up.

Mayor Zelenko said if we do this, you will assume the liability.

Mr. Heffner said, of course.

Mr. Haskins stated the decrease to 4.0 mills didn't stop a single road project. Thank you to the DPW workers that are out there working hard. The residents have noticed.
